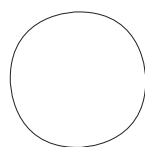

### Membership fees

One member £15.00 annually.  Two members at the same address £30.00 annually.

These fees include a £3.50 membership fee paid to our national organisation, the Third Age Trust, which provides a wide range of services and benefits, including liability insurance cover. If you are applying to join after the start of the membership year, the fees are as follows: From April to September: £15.00. If you join after the end of September the fee is: £10.00.

If you belong to another U3A, the annual membership fee is reduced by the amount of the Capitation Fee, providing you can supply proof of membership. N.B. This only applies to full year membership.
